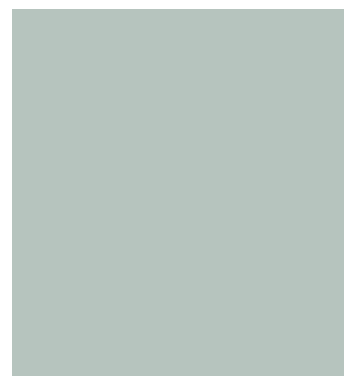

2024 WiS Cabinet

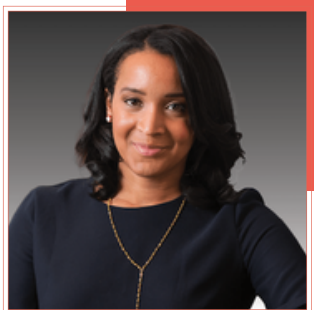
